Advancing Access & Taking Action for the Nation's Oral Health is the theme for the **2007 National Oral Health Conference** as we share a day of programming with the **19th Annual Meeting on Special Care Dentistry**. Join us at the Marriott Denver Tech Center for a conference that promises a wide variety of educational sessions, expert speakers and extra networking time with colleagues.

Three full days of conference sessions are planned April 30 – May 2, 2007 with May 2nd the day of joint programming with the Special Care Dentistry Association. Participants may also stay on for two additional days of programming at the SCD meeting. Pre-conference meetings and educational sessions will be held April 27 - 29, 2007. The American Board of Dental Public Health will be offering the Specialty Board Exam to candidates on April 26-28, 2007.

This is the eighth joint meeting between the **Association of State and Territorial Dental Directors** (ASTDD) and the **American Association of Public Health Dentistry** (AAPHD) and its sponsors – the **Health Resources and Services Administration** and the **Centers for Disease Control and Prevention**. Over 1000 participants are expected over the five days of NOHC and SCDA programming along with 40 exhibitors.

The National Oral Health Conference will offer scientific sessions in a variety of formats: large plenary sessions, smaller concurrent sessions and poster presentations. The popular lunch & learn roundtables will be expanded and offered on the joint day of programming on Wednesday, May 2nd. Sessions will focus on issues and topics relevant to research, education and programs, highlighting how all these areas of public health integrate toward achieving the goals of "Advancing Access and Taking Action for the Nation's Oral Health!"

This conference is designed for dentists, dental hygienists, health researchers, dental or health educators, legislators, public health officials, Medicaid/SCHIP dental representatives, state/territorial dental directors, county/city/local dental directors, community health center personnel, students, federally-employed dental personnel, as well as dental suppliers and dental insurance companies. Will Today's Dental Public Health Workforce Meet Tomorrow's Needs?
