Development of the Comprehensive State Oral Health Plan



- Disease burden kickoff with Healthy
 Alaskans mid-course review (Nov. & Dec. 2005)
- Public Health community familiar with HP process and objectives

Healthy People 2010 Focus: 2002 - 2010 Infrastructure Development & Surveillance

- Objective 21-17: State Infrastructure State health agency dental public health program (CDC-funded implementation in July 2002)
- Objective 21-16: Surveillance System Establish an oral health data system to collect/store information on status, trends, resources and needs.
- Objective 21-8: Dental Sealants Basic Screening Survey (BSS) 3rd grade sealant utilization at 55% (2007); most village/rural schools have school-based/linked sealants
- Objectives 21-1 & 21-2: BSS (2004-2007) highlighting child caries experience, untreated caries and early childhood caries.
 - Medicaid/CHIP Dental Access
 - Water fluoridation
 - Collaboration with MCH and Head Start

Healthy People 2010 Focus: 2002 - 2010 Infrastructure Development & Surveillance

- Objective 21-9: Support and management of community water fluoridation (an ongoing effort)
 - CDC Water Fluoridation Reporting System (WFRS): First CDC
 Quality Awards 2003 State CWF Award Process developed
 - Tribal-sponsored water operator training at least annually oral health program presentations at annual water operator conferences
 - Local initiatives/activities to implement CWF or to discontinue fluoridation
- Objectives 21-10 21-11: Use of the oral health care system
 - Enhanced dental services for adult Medicaid recipients
 - CHC dental expansions
 - Increasing private dental participation in Medicaid.

Healthy People 2020 Focus Infrastructure Maintenance & Policy Development

- · Sustainability of the state oral health program
- Access to the oral health care system
 - Dental workforce activities
 - Medicaid/CHIP Policy EPSDT Guidance
- Oral cancer exams and Tobacco Control
 - Increase oral cancer exams
 - Engaging dental providers in tobacco cessation education/referrals
- Partnerships with chronic disease programs
 - BSS dental assessments (height & weight data)
 - Increase routine dental exams for individuals with diabetes

Determinants of Health

- Oral Health Program has highlighted socioeconomic status and racial/ethnic disparities as it relates to oral diseases.
- HP2010 Even more focus on reducing disparities and beyond Native v. non-Native
- Expect to continue highlighting underlying socioeconomic aspects related to health with the HP2020 process.
