Healthy and Well Kids in Iowa

- Covers up to 300% of poverty level
 - Increased from 200% July 1, 2009



- 37,749 eligible for at least one month in SFY 2009
- Dental is "carved out"
- Added dental only effective March 1, 2010
 - Expect 22,200 additional enrollments
- Includes orthodontia

Iowa Medicaid

- Fee for Service
 - 51.3% of median retail rates
 - Reduced 2.5% effective December 1, 2009



Administration



Adults

- 35% of eligible adults received a dental service in FY 09
- Expenditures equaled 42% of the total dental expenditures

Adult Coverage

- Comprehensive coverage until March 1, 2002
 - Posterior Crowns
 - Periodontal Treatment
 - Posterior Endodontia
 - Orthodontia
- Restored December 1, 2009
 - All except orthodontia




Provider Participation

Includes:

- Oral Health Education
- Dental Screenings
- Preventive Services
- Diagnostic Services
- Treatment Services
- Emergency Services

- Services provided where at-risk families are found
 - Physician's offices during well-child exams
 - WIC clinics
 - Preschools

- 24 Oral Health Care Coordinators
- Located within the Title V Child Health Agencies



- Build partnerships within communities
- Link with local Boards of Health
- Education and training for health care providers about children's oral health
- Develop oral health protocols
- Ensure care coordination and assist with referrals to dentists

- Ensure completion of screenings and risk assessments
- Gap-filling preventive services
