# Coordinated Chronic Disease Prevention and Health Promotion

- More effectively address common risk factors, e.g. poor diet, physical inactivity, obesity, smoking
- Shift to systems and environmental approaches
- Improve program efficiencies
- Sharing of resources among categorical programs
- Increase flexibility to address context
- Improve CDC technical assistance

## **Enhancing Coordination**

- Purpose: Work collaboratively across NCCDPHP and with state and community partners to efficiently and effectively implement chronic disease prevention and health promotion strategies
- □ Goals:
  - Implement a focused Chronic Disease Prevention & Health Promotion agenda
  - Maximize efficient use of resources
  - Improve support for and share technical expertise with states and communities
  - Support chronic disease prevention and health promotion programs in every state
  - Improve population health

### **Chronic Disease Domains**


- Domain 1: Epidemiology and Surveillance: Gather, analyze, and disseminate data and information and conduct evaluation to inform, prioritize, deliver, and monitor programs and population health
- Domain 2: Environmental Approaches: Approaches that promote health and support and reinforce healthful behaviors
- Domain 3: Health System Interventions: Improve the effective delivery and use of clinical and other preventive services
- Domain 4: Community-Clinical Linkages: Improve community-clinical linkages ensuring that communities support and clinics refer patients to programs that improve management of chronic conditions

## **History of Coordination Efforts - funding**

- 4 states Pilot negotiated agreement for flexibility in program integration
- 50 states supplemental funding (FY 2011) to:
  - Develop a state chronic disease plan
  - Develop assessment & management plan for leadership in chronic disease prevention
  - Build capacity and achieve changes in 4 domains
- Combined Funding Announcement for diabetes, heart disease and stroke prevention, nutrition and physical activity, and school health (FY 2013) (FOA 13-1305)


### **Coordinated Efforts within NCCDPHP**

- Create Coordinated State Support Branch in Division of Population Health
- Formation of Regional Teams to improve technical assistance (TA)
- Incorporate coordination language into all new funding announcements
- Realign program Project Officers to Regional assignments
- Staffing of Regional Team Coordinators



### **Coordinated Efforts within NCCDPHP**

- Training of program Project Officers
- Periodic Regional Team meetings within NCCDPHP
- Conduct Regional TA Workshops for state Chronic Disease Directors
- Partner with NACDD to develop Chronic Disease Events Calendar for program training opportunities



## **Opportunities for Oral Health Programs**

- Provide input into state chronic disease plan
- Flexibility to share resources/positions
- Broaden partnerships and support
- Joint program efforts, e.g., BSS and BMI, tobacco control, diabetes
- Leveraging and synergies
- CDC oral health funding or location in state Chronic Disease Section not required
