New Hampshire's 2009 Healthy Smiles-Healthy Growth Third Grade Survey

- NH's Statewide Third Grade Oral Health Surveys 2001, 2004, 2009 collected surveillance data.
- ASTDD Basic Screening Survey assesses student oral health status
- In 2009 NH added height/ weight assessment to:
 - Share limited state resources (funding & workforce) through collaboration.
 - Maximize school-based data collection/ minimize classroom disruption.
 - Raise awareness of relationship between nutrition, oral health & obesity.
 - Raise awareness that harmful eating behaviors impact oral health.
 - Standardize school data collection with equipment and assessment protocols.
 - Show that good data drives programs and motivates communities to act.

Lessons Learned

- NH schools are comfortable with services delivered by program RDH's.
- Obesity- a more sensitive topic in schools than OH.
- Required negotiation with some school administrators.
- 100% participation of schools in selected sample.
- Concerns from school food services.
- NH school OH programs must take disease prevention interventions to young high-risk children in Head Start, WIC and child care.
 - Integrated parent participation and nutrition education


Outcomes

- Integrate oral health with children's total health
- School OH programs have adopted "teeth to toes" total health approach
- Monadnock Healthy Teeth to Toes
- Healthy Me After School Program-physical activity, recipes for healthy snacks
- Added new schools to school-based oral health programs
