#### ADA Governance

The House of Delegates, as the legislative and governing body, is the supreme authority in the American Dental Association.

The Board of Trustees is the managing body of the Association, vested with the power to conduct all business of the Association.

There are 11 ADA councils with most composed of one member from each of the 17 trustee districts of the Association.

### CAPIR's Mission

The Council on Access, Prevention and Interprofessional Relations (CAPIR) is the primary agency dedicated to providing leadership, vision, and coordination of the ADA's activities to:

- advance oral health care within the health delivery system
- promote prevention as the cornerstone of oral health
- improve access to oral health services for underserved populations




# Here's what the plan says:
